

## 香港郵政電子證書(機構)"具自動交換資料功能"附加申請表格 Supplementary Application Form

## for Hongkong Post e-Cert (Organisational) with AEOI Functions

#### 注意事項 Note

- (1) 此表格適用於申請電子證書(機構)"具自動交換資料功能"。申請人須就**每一位**獲機構授權使用電子證書(機構)"具自動交換資料功能"登入稅務局的「自動交換資料網站」/「國別報告網站」的授權用戶,遞交一份附加申請表格。
- (2) 如屬電子證書(機構)"具自動交換資料功能"之新申請,申請人須填妥本附加申請表格,並附上有關的文件,連同香港郵政電子證書(機構/保密/伺服器)申請表格(CPos 798F)一起遞交。
- (3) 如屬現有的電子證書(機構)之續期申請,並欲增加"具自動交換資料功能",申請人須填妥此附加申請表格及附上有關的文件,連同"香港郵政電子證書(機構)一證書續期表格"(CPos 792G\_C)一起遞交。
- (4) 授權用戶之香港身份證或護照副本須連同此附加申請表格一起遞交。授權用戶須在香港身份證或護照副本上簽署,簽署須與此附加申請表格的簽署相同。
- (1) This form is used for applying for the e-Cert (Organisational) with AEOI Functions. The Applicant shall submit one supplementary application form for **each** Authorised User who is authorised by the Organisation to use the e-Cert (Organisational) with AEOI Functions to access the AEOI Portal / CbC Reporting Portal of the Inland Revenue Department ("IRD").
- (2) For new application of e-Cert (Organisational) with AEOI Functions, the Applicant shall submit the supplementary application form(s) and the relevant supporting documents together with the "Application Form for Hongkong Post e-Cert (Organisational / Encipherment / Server) Certificate" (CPos 798F).
- (3) To add the AEOI Functions to the existing e-Cert (Organisational) upon renewal application, the Applicant shall submit the supplementary application form(s) and the relevant supporting documents, together with the "Hongkong Post e-Cert (Organisational) Certificate Certificate Renewal Form" (CPos 792G).
- (4) A copy of the Authorised User's HKID card or passport shall be submitted together with the supplementary application form. The Authorised User shall sign on the copy of his/her HKID card or passport with the same signature as he/she signed in this supplementary application form.

If you wish to do so, please complete the Data Access Request Form (Pos736) or Personal Data Correction Request Form (Pos736A) and return it to any post office or send it to our Personal Data Privacy Officer by e-mail or by post. The Data Access Request Form and Personal Data Correction Request Form are also available at all post offices.
