Subscriber Terms and Conditions of e-Cert (Personal) with "Mutual Recognition" Status **Important: Read Carefully**

The Hong Kong Post Office ("HKPost") as represented by the Postmaster General and the Applicant of

- Hongkong Post e-Cert ("e-Cert(s)"), intending to be legally bound, hereby agree as follows:

 1. The Certification Practice Statement ("CPS") governs the issuance of e-Certs and certification services provided by HKPost. The CPS is publicly accessible at the HKPost website at
- http://www.eCert.gov.hk.

 By submitting the e-Cert Application Form, the Applicant confirms to have read and understood these Terms and Conditions and have full notice of the obligations and liabilities of the Subscribers
- these Terms and Conditions and have full notice of the obligations and liabilities of the Subscribers and Relying Parties as set out in the CPS.

 HKPost has designated the e-Cert (Personal) with Mutual Recognition Status to participate in the mutual recognition scheme under the Mutual Recognition Arrangement. For the specific certificate types with mutual recognition status and the verification method of these certificate types. Deseave feet to the official trust list published by the Economic and Information Commission of Guangdong Province to confirm whether the certificate types have valid mutual recognition status and their validity period. - HKSAR. The parties agree to submit to the exclusive jurisdiction of the Courts of HKSAR.

 The submission of the e-Cert Application Form and its receipt by HKPost do not guarantee approval of the application. If the application is rejected, the Applicant will be notified of the rejection. If the application is approved, the Applicant shall be bound by these Terms and Conditions as well as the provisions of the CPS.

電子證書(個人) "互認版"的 《登記人條款及條件》 重要資料:務請細閱

由香港郵政署長代表的香港郵政署("香港郵政")與香港郵政電子證書("電子證書")的申請人擬達 成以下協議並接受法律約束

- 《核證作業準則》("《準則》")規管香港郵政簽發電子證書及提供核證服務事宜。《準則》 載於香港郵政網頁(網址:http://www.eCert.gov.hk),供公眾人士查閱。
- 申請人遞交電子證書申請表格,即確認已閱讀並明白本條款及條件,且完全知悉《準則》 所列的登記人及倚據人士的義務及法律責任。
- 香港郵政已指定電子證書 (個人) "互認版"參與《粤港兩地電子簽名證書互認辦法》下 的證書互認計劃。有關具互認資格的特定證書類別及這些證書類別的互認識別方法,請參 閱廣東省經濟和信息化委員會發布的官方信任列表,以確定證書類別是否具互認資格及其 有效期。政府資訊科技總監辦公室亦會在其信任列表備存有關資料的副本,以供參考。
- 本條款及條件連同《準則》構成《準則》所提述香港郵政與申請人訂立的整份《登記人協 議》,並取代香港郵政與申請人所有先前或現時有效並關乎發出電子證書的協議或諒解協

 - b) 同意受(i)本條款及條件及(ii)《準則》條文的約束;
 - c) 同意有關使用私人密碼匙及電子證書的風險全由登記人承擔;
 - d) 同意香港郵政從未就香港郵政簽發的私人密碼匙及電子證書作出任何隱含或明示的保證;
 - 承諾如未有妥善履行或不曾履行本條款及條件以及《準則》內列明的責任,則或須就香 港郵政及 / 或其他人(包括倚據人士)因此而招致或蒙受的法律責任或損失及損害,向其 支付損害賠償
 - 承諾採取合理預防措施,保護其私人密碼匙的機密性(即予以保密)及完整性,以免丢 失、外泄或遭人擅自使用;
 - g) 承諾一旦發現私人密碼匙有任何丢失或外泄,以及/或出現電子證書應予撤銷的情況時 · 立即作出涌報:
 - h) 同意倘其香港身份證遭入境事務處或其他執法機關根據中華人民共和國香港特別行政區 ("香港特區") 法例沒收,則放棄使用任何載於其香港身份證內的私人密碼匙,而香港 郵政及香港特區政府無須就任何此等情況對申請人負上任何責任;
 - 批准將電子證書向任何其他人公布或在香港郵政儲存庫內公布,並接受將予發出的電子證
 - 同意香港郵政署長可局限他/她及/或香港郵政因疏忽及/或違反《進則》、本條款及條 件、及/或香港郵政所簽發私人密碼匙及/或電子證書內列明的合約而引致的法律責任 ; 以及
 - k) 同意香港郵政署長可以指定其他代理人或分包商履行其在《準則》及/或本條款及條件 下的義務
- 7. 申請人(並於接受向其簽發的電子證書時成為登記人),向香港郵政保證(承諾)並向所 有其他有關各方 (尤其是倚據人士) 表述,下開事實在電子證書有效期間俱屬真確並將保 持真確
 - 任何其他人均不能取用其私人密碼匙;
 - b) 電子證書內由其提供的一切資料及作出的申述均為屬實;以及
 - 私人密碼匙及電子證書只用作經授權及合法的用途,而使用方式不會侵犯任何第三者權益。
 - d) 申請人在使用電子證書進行電子簽名時,應確保該證書沒有過期或被撤銷
- 8. 根據《準則》,香港郵政有責任使用可靠的系統以:
 - a) 及時發出及公布電子證書;
 - b) 通知申請人其申請被拒;
 - c) 通知申請人其申請獲批及如何提取其電子證書;
 - d) 撤銷電子證書並及時公布"電子證書撤銷清單";以及
 - e) 通知登記人其電子證書被撤銷。
- 登記人承諾向香港郵政支付《準則》所指明的每個登記使用期的登記費用。登記費用須於 每個登記使用期開始前支付,除非獲香港郵政以書面豁免。香港郵政保留絕對權利不時檢 討及釐定登記費用,並於香港郵政網頁(網址: http://www.eCert.gov.hk)公布,讓登記人及公 眾人十有所知悉
- 10. 若本條款及條件的任何條文或任何條文的任何部分被法庭裁定為非法、無效或不可執行, 則其將被分割及刪除,但此並不影響本條款及條件的其餘條文或任何條文的其餘部分的有 效性及可執行性。
- 11. 本條款及條件受香港特區法律管限,並按香港特區法律詮釋。協議各方同意接受香港特區 法院的專有司法管轄權管轄
- 12. 香港郵政收到申請人遞交的電子證書申請表格,並不保證申請會被批准。如申請被拒,申 請人將接獲通知。如申請獲批,申請人須受本條款及條件以及《準則》條文的約束。
